IMPORTANT INFORMATION

- 1. Passengers who are not taking any articles included on the reverse side shall not fill out this form and may choose to go through the "NOTHING TO DECLARE" ("GREEN CHANNEL", marked " ").
- 2. Passengers who are taking any articles included on the reverse side shall complete truthfully declaration form and submit it to the Customs officer at the declaration desk and shall follow the "GOODS TO DECLARE" ("RED CHANNEL", marked ""). Passengers who are exempted from Customs control in accordance with relevant regulations and those under the age of 16 traveling with adults, shall not fill out this form.
- 3. Keep this form intact for return voyage.
- "Residents" listed in this form refers to passengers residing in China's Customs territory. "Non-residents" listed in this form refers to those passengers residing out of China's Customs territory.
- 5. False declarations may result in penalties by the Customs.

ARTICLES PROHIBITED FROM IMPORTATION IN ACCORDANCE WITH THE LAW OF THE PEOPLE'S REPUBLIC OF CHINA

- 1. Arms, imitation arms, ammunition and explosives of all kinds.
- 2. Counterfeit currencies and counterfeit negotiable securities.
- 3. Printed matters, films, photographs, gramophone records, cinematographic films, tapes (audio and video), compact discs (audio and video), storage media for computers and other articles which are detrimental to the political, economic, cultural and moral interests of China.
- 4. Deadly poison of all kinds.
- 5. Opium, morphine, heroin, marihuana and other addictive drugs and psychotropic substance.
- 6. Fruits, solanaceae vegetables, live animals (except dogs and cats as pet), animal products, pathogenic micro-organisms of animals and plants, pests and other harmful organisms, animals carcasses, soil, genetically modified organisms, relevant animals and plants, their products and other quarantine objects from countries or regions with prevalent epidemic animal or plant diseases.
- 7. Foodstuff, medicines and other articles coming from epidemic stricken areas and harmful to man and livestock or those capable of spreading diseases.

ARTICLES PROHIBITED FROM EXPORTATION IN ACCORDANCE WITH THE LAW OF THE PEOPLE'S REPUBLIC OF CHINA

- 1. All the articles prohibited from importation in accordance with the law of the People's Republic of China.
- Manuscripts, printed matters, films, photographs, gramophone records, cinematographic films, tapes (audio and video), compact discs (audio and video), storage media for computers and other articles which involve the state secrets.
- 3. Valuable cultural relics and other relics prohibited from exportation.
- Endangered and precious rare animals and plants (including their specimens), and their seeds and reproducing materials.
