I HEREBY CONFIRM THAT I GAVE UP MY LAST USUAL PLACE OF RESIDENCE IN THE DESIGNATED COUNTRY OF ORIGIN ON AND THAT, BEFORE I ESTABLISHED MY NEW USUAL PLACE OF RESIDENCE IN BELGIUM, I HAVE CONTINUALLY, OR DURING AT LEAST TWELVE CONSECUTIVE MONTHS (IMMEDIATELY PRIOR TO THE DATE OF THE ESTABLISHMENT OF MY NEW USUAL PLACE OF RESIDENCE IN BELGIUM) HAD MY USUAL PLACE OF RESIDENCE OUTSIDE THE TERRITORY OF THE EUROPEAN ECONOMIC COMMUNITY.

I DECLARE THAT THE DATE ON WHICH I ESTABLISHED MY NEW USUAL RESIDENCE IN BELGIUM IS

I CONFIRM AS WELL THAT I AM INFORMED OF THE FACT THAT ALL GOODS CONCERNED WHICH I WISH TO IMPORT WITH EXEMPTION MUST BE IMPORTED AND DECLARED BEFORE A PERIOD OF TWELVE MONTHS ELAPSES FROM THE DATE ON WHICH I ESTABLISHED MY USUAL PLACE OF RESIDENCE IN BELGIUM, AND ALSO OF THE LEGAL PROVISION CONCERNING THE FACT THAT THE GOODS WHICH WERE ADMITTED WITH EXEMPTION, MAY NOT BE LOANED, PAWNED, RENTED OR TRANSFERRED BY ME EITHER INDEBTEDNESS OR GRATUITOUSLY, UNTILL A PERIOD OF TWELVE MONTHS ELAPSES FROM THE DATE ON WHICH THE DECLARATION OF THE GOODS IS ACCEPTED BY THE CUSTOMS FOR FREE PASSAGES, UNLESS I PREVIOUSLY INFORM THE APPROPRIATE CUUSTOMS AUTHORITIES (NAMELY THE HEAD CONTROLLER OF THE CUSTOMS IN THE AREA WHER MY USUAL PLACE OF RESIDENCE IS LOCATED)

I UNDERSTAND THAT, IF I SHOULD DISPOSE OF SOME OR ALL OF THE GOODS CONCERNED IN ONE OR THE ABOVE MENTIONED WAYS WITHIN THAT PERIOD, I BECOME LIABLE TO PAY THE IMPORT DUTY AND VAT APPLICABLE TO THOSE GOODS.

I BIND MYSELF TO OBSERVE THESE PROVISIONS AND ALSO TO PROVIDE COMPLIANCE TO THE APPRIATE CUSTOMS AUTHORITIES TO MAKE IT POSSIBLE FOR THEM TO CARRY OUT ANY INSPECTIONS, WHICH THEY MIGHT CONSIDER.
